# O GENERAL REGULATIONS

#### **ARTICLE 1. DATES**

The seventh edition of the Festival TAKAVOIR, will take place in Niort on March 26, 2016.

## **ARTICLE 2. ORGANIZATION**

## **ARTICLE 3. ENTRY CONDITIONS**

The participation in TAKAVOIR Festival is open exclusively to films created with mobile phone and/or non-professional digital cameras that fit in a hand.

The genre of the films is open. **The length is limited to 3 minutes (credits inclusive).** Films can be edited inside or outside the mobile phone or non-edited. Participation is free-of-charge.

#### **ARTICLE 4. REGISTRATION FOR PRESELECTION**

The registration for the TAKAVOIR Festival will be done exclusively via the website <a href="www.takavoir.fr">www.takavoir.fr</a>. A registration form must be fully completed for each film submitted to the festival. The films-makers will have to indicate the link of their movies

To validate a submission the participants must fill out **entirely** the inscription form and send the required materials – a CD or DVD or via WeTransfer (any formats) containing :

- -The film
- -Three photos of the film (72 bpi) to the following address:

We also invite film-makers to send us their picture.

The deadline for registration (i.e., the date at which the film on CD or DVD must be received at the office of hORS cHAMPS) is February 28, 2016.

# **ARTICLE 5. SELECTION**

The selection committee of the TAKAVOIR Festival will choose, among the films submitted, those to be selected to take part in the competition.

The chosen film-makers will be notified before the festival opens.

An mail confirming the reception and the registration of the movie will be send to participants as soon as hORS cHAMPS recieves the film fully and duly registred.

## **ARTICLE 6. PROMOTION**

For the purpose of promoting this edition of the TAKAVOIR Festival and for the next two editions to come, hORS cHAMPS will be free (participants authorized hORS cHAMPS) to diffuse the names, address, and pictures of the participants and any extract of the selectionned films to all print media, television, Internet and/or wap sites, and by any electronic means of communication to the public.

## **ARTICLE 7. DIFFUSION OF FILMS**

# **Before the festival TAKAVOIR**

The preselected films will be broadcast on the website <a href="www.takavoir.fr">www.takavoir.fr</a> and on all the others partners' websites, starting from February 28 , 2016.

# **During the festival**

The selected films will be shown during the festival on the website <u>www.takavoir.fr</u> and during the event on March 26, 2016.

#### After the festival

For the purpose of promoting and valorizing on a non commercial basis, hORS cHAMPS is authorized to diffuse the films, from their date of reception by the Festival, to **three years** after the Festival, on all the partners' websites, Waps and in other festivals in which TAKAVOIR could be invited.

The film-makers taking part grant these permissions free of charge, and consent, for a period of **THREE YEARS**, to refrain from giving the rights to show their films.

For the purposes of the screenings mentioned above, hORS cHAMPS may copy the films and adapt them, exclusively for reasons related to the ergonomic, technical and graphic constraints of the receiving terminals.

All participating film-makers declare themselves to be the legal owners of all the rights relating to the copying, representation and diffusion of their films. hORS cHAMPS informs all film-makers that the use of pre-existing works of music in films requires written permission from the copyright owners.

The filmmaker consents to the diffusion of his/her film according to the conditions defined within the Creative Commons Paternité licence "Attribution Noncommercial 2.0 France" in order to better serve the non-commercial diffusion of his/her work. Film-makers will be personally liable in case of complaints ensuing from the diffusion of their films by hORS cHAMPS and will guarantee hORS cHAMPS against any loss or damage it may sustain.

#### **ARTICLE 8. AWARDS**

A jury made up of professionals from the world of cinema will give the following prices

- Le Grand Prix du JURY > 1.000 €
- Le Prix de la Ville de Niort > 500 €
- Le Prix Jeunesse Banque Populaire > 500 €

The public will vote for a film during the festival

• Le Prix du Public > 150 €

A jury constituted with high school students will give 2 rewards for the **Concours "Jeunes Réalisateurs" (young film makers contest)** 

#### **ARTICLE 9. ORGANIZERS' RESPONSIBILITIES**

TAKAVOIR Festival reserves the right to use the information in the registration forms under the conditions specified in law 78.17 of January 6, 1978. hORS cHAMPS shall not be in any way liable in any of the above cases. No compensation of any kind will be due to entrants.

#### **ARTICLE 11. ADHERING THE FESTIVAL**

Any contestation about the interpretation or application of the present regulation will be submitted to the appreciation of hORS cHAMPS without prejudice or appeal to the Tribunal de Grande Instance de Niort .
